WHY ?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this paties carefully to understand what we do
WHAT ?	<ul> <li>this notice carefully to understand what we do.</li> <li>The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul> <li>Social Security Number</li> <li>Credit Scores and Credit History</li> <li>Account balances</li> </ul> </li> </ul>
HOW ?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information, the reasons TVACCU chooses to share, and whether you can limit this sharing.

Reasons we can share your personal information	Does TVACCU share?	Can you limit this sharing?
For our everyday business purposes - such as to process your transactions, maintain your account(s), respond to court orders and legal investigations, or to report to credit bureaus	YES	NO

How does TVA Community Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safegaurds and secured files and buildings.		
How does TVA Community Credit Union collect my personal information?	<ul> <li>We collect your personal information, for example, when you:</li> <li>open an account</li> <li>apply for a loan</li> <li>show your government-issued ID</li> <li>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</li> </ul>		
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only:</li> <li>sharing for affiliates' everyday business purpose</li> <li>affiliates from using your information to market to you</li> <li>sharing for nonaffiliates' to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing.		

Definitions			
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. - TVA Community Credit Union has no affiliates		
	Companies not related by common ownership or control. They can be financial and nonfinancial companies.		
Nonaffiliates	- Non affiliates we share with can include insurance companies, government agencies, DEBIT/CREDIT/ATM card processors, financial statement publishers, mailhouse, credit reporting agencies, data processors, and direct marketing companies		
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
