Interest will continue to accrue on the balance of the loan from the last payment date. Loans must be open at least 90 days and in good standing to qualify. All other terms and conditions of the loan(s) will remain. Gap insurance may not apply to the extended loan term. If paying a \$35 fee through a transfer from a share of share draft account, funds must be available over any minimum balance requirement to cover the fee at the time this form is processed. The primary and all joint/co-signing members/owners must sign the request form to skip the loan(s). Subject to credit union terms and conditions, may be changed without prior notification.
